Guidance for Enlisted Personnel Dining Facilities July 2020

1. This guidance to be used in the planning, design and/or solicitation development of EPDF in response to MILCON requirements. It is critical that new EPDF meet the necessary functional criteria to support Army Transformation and incorporate MILCON Transformation objectives to reduce construction and sustainment costs.

2. Facility serving requirement must be established for each facility and is determined by the serving requirement. The maximum number of enlisted personnel to be served during each meal period will be determined by multiplying the maximum utilization Unaccompanied Enlisted Personnel Housing (EPDF) capacity by the applicable percentage(s) provided in the table below; Enlisted personnel on separate rations, along with officers and civilians **will not be included** in the serving requirement when planning a new dining facility, or retaining and modernizing permanent existing dining facilities, except in OCONUS or remote locations where support is authorized. The resulting number determines the standard size dining facility to be used.
